F. Consider Resolution No. 2019-05, authorizing the Board Chairperson to enter into a Master Development Agreement between Collaborate Special Projects LLC, Village Center Local Government Corporation, and the City of Jersey Village.

The Board engaged in discussion about Article 2.1.2(d), which reads as follows:

"Hotel. As further detailed in the Hotel Agreement, Hotel Owner intends to develop and construct the Hotel, having the Mandatory Design Elements described in this Agreement, provided that CSP may modify the Mandatory Design Elements for the Hotel (other than those set forth on Exhibit D-5) without the consent of any other Party so long as the Hotel continues to comply with the Ordinance."

Some members were concerned about giving the Hotel Owner the ability to modify without consent. The reasons why this language is needed were also discussed. It was mentioned that the Hotel owner will still need to abide by D5. Some felt that Article 2.1.2(d) was more for the interior of the Hotel and Article D5 outlines what is required on the exterior.

In connection with both Articles, branding was discussed by the Directors.

With no further discussion on the matter, Director Warren moved to approve Resolution No. 2019-05, authorizing the Board Chairperson to enter into a Master Development Agreement between Collaborate Special Projects LLC, Village Center Local Government Corporation, and the City of Jersey Village. Director Wubbenhorst seconded the motion. The vote follows:
